Remote Participation and Voting

- 1. Only shareholders whose names appear on the Record of Depositors as at 8 June 2021 shall be eligible to participate in the EGM or appoint proxy(ies) to participate and/or vote on his/her behalf.
- 2. Since the EGM will be conducted virtually, shareholders/proxies will not be allowed to be physically present at the Broadcast Venue.
- 3. Shareholders who wish to participate at the EGM are required to register as a user of Dvote Online at https://Dvote.my as well as register for the Remote Participation by login to https://Dvote.my/user-login with your user ID. Registration for Remote Participation will remain open from 10 June 2021 until the commencement of the polling during the virtual EGM.

Appointment of Proxy

- 1. Shareholders who are unable to participate in our Virtual EGM are encouraged to appoint the Chairman of the EGM as your proxy and indicate the voting instructions in the Form of Proxy.
- 2. The appointment of proxy may be made in hard copy or in electronic form. The instrument appointing a proxy must be submitted in the following manners, at least forty-eight (48) hours before the time for holding the EGM or any adjournment thereof:-

(i) In hard copy form

Appointed proxies are required to register as a user of Dvote Online at https://Dvote.my as well as register for the Remote Participation by login to https://Dvote.my/user-login with your user ID. Registration for Remote Participation will remain open from 10 June 2021 until the commencement of the polling during the virtual EGM.

Revocation of Proxy

If you have submitted your Form of Proxy and subsequently decide to appoint another person or wish to participate in the Virtual EGM by yourself, please write in to Khairul.lqram@boardroomlimited.com to revoke the earlier appointed proxy forty-eight (48) hours before the time for holding the EGM or any adjournment thereof.

Submission of Questions

- 1. Shareholders that wish to post questions to the Chairman/Board/Management can email their questions to ccid@kelington-group.com no later than 9:30 a.m. on Monday, **14 June 2021**.
- 2. Shareholders may also submit their questions to the Chairman/Board/Management via the real time submission of typed texts through a text box within Dvote Online platform before the start or during the live streaming of the EGM.
- 3. The Chairman/Board/Management will endeavour to respond to relevant questions during the EGM or by email after the EGM.

Poll Voting

The voting at the Virtual EGM will be conducted by poll in accordance with Paragraph 8.29A of Main Market Listing Requirements of Bursa Malaysia Securities Berhad.

Kelington Group Berhad has appointed Dvote Services Sdn. Bhd. ("**Dvote**") as Poll Administrator to conduct the poll by way of electronic voting or online remote voting ("**e-voting**").

Kindly refer to item no. 2 of the below Dvote Online User Guide for guidance on how to vote remotely from Dvote Online website at https://Dvote.my.

During the Virtual EGM, the Chairman of the EGM will invite the Poll Administrator to brief on the e-Polling housekeeping rules. The voting session will commence as soon as the Chairman of the EGM calls for the poll to be opened and until such time when the Chairman of the EGM announces the closure of the poll.

For the purposes of the Virtual EGM, e-voting will be carried out via personal smart mobile phones, tablets or personal computers/laptops.

Upon the conclusion of the poll session, the Scrutineers will verify the poll results followed by the declaration by the Chairman of the EGM whether the resolutions put to vote were successfully carried or not.

Dvote Online User Guide

Kindly follow the steps below on how to register, request for login ID and password:-

1. REMOTE PARTICIPATION AND E-VOTING FACILITIES

Members to attend, speak (in the form of real time submission of typed texts) and vote (collectively, "Participate") remotely at the Virtual EGM using RPV Facilities provided by Dvote via its **Dvote Online** website at https://Dvote.my. Please refer to Procedure for RPV Facilities.

(a)	Sign-up as a user with Dvote Online	 Note: If you are already a user with Dvote Online, you are not required to sign-up again. You may proceed to sign-in using your email address and password. Access the website at https://Dvote.my. Click on Sign up to register as a new user with Dvote Online. Complete registration and upload softcopy of Malaysia Identification card (front and Back) or passport (foreigner(s). You will be notified via email once your user registration is accepted/rejected by Dvote Online.
(b)	Register Meeting with Dvote Online	 Registration for Remote Participation will remain open from 10 June 2021 until the commencement of the polling during the virtual EGM. Login to https://Dvote.my/user-login with your user ID (i.e.: email address) and password. Select event: "Kelington Group Berhad – Extraordinary General Meeting" and click Register. You will receive an email notifying on your registration for the remote participation and verification. Once your registration has been verified against the Record of Depositors as at 8 June 2021 you will be notified via email whether your request for remote participation is approved/rejected. If approved, you will receive an invitation email together with the meeting link to "Join Meeting".

Post Questions during Live Streaming	If you have any question(s) for the Board of Directors, you may use the Post Question box to transmit your question(s).	
Online Voting during Live Streaming	 Click on Proceed to Vote, to cast your votes for each resolution(s). Review your casted votes, confirm and submit your votes. 	
End of remote participation	Upon the announcement by the Chairman on the closure of the Virtual EGM, the live streaming room will end.	

Notes to users of the RPV Facilities:

- The quality of the live streaming is highly dependent on the bandwidth and stability of the internet connection at the location of the user and the device of the user.
- Users are advised to afford themselves ample time to complete the log in process in advance of the meeting.
