Another One For The Road; Stay BUY

- **Stay BUY and MYR6.10 TP, 19% upside, c.2.7% FY26F yield.** Kelington Group's 4Q25/FY25 results were in line with our forecast but a consensus beat, with quarterly earnings hitting another high on sustained margins. We expect the robust earnings momentum to continue into FY26, supported by an outstanding orderbook of MYR1.4bn and tenderbook exceeding MYR4bn. A 6% ESG premium is reflected in our TP given KGB's 3.3 score.
- **Record earnings and dividends.** FY25 core earnings of MYR158.9m (+22% YoY) were c.4% ahead of our forecast on stronger-than-expected margins but exceeded consensus estimate at 108% with 4Q25 core profit notching another quarterly record (+32% QoQ, +59% YoY) on seasonally stronger revenue and stable NPM QoQ. A 4 sen final DPS (inclusive of a 1.5 sen special DPS) brings cumulative DPS to 13 sen (FY24: 8 sen) with DPR at 66.4%.
- **FY25 EBIT grew 16% YoY as GPM expanded 2% to 21.4%**, with the continued focus on higher-margin projects. The advanced engineering segment remained the dominant contributor (FY25: 67% of revenue) with flattish revenue development YoY. This is as stronger Singapore revenue (+35% YoY) and maiden contributions from Europe (MYR20.6m) offset weaker showings from Malaysia (-10%) and China (-25%) – the latter was clipped by delays in the procurement of tools. Industrial gas revenue fell 13% YoY on lower specialty gas sales, mitigated in part by steady LCO2 demand.
- **Outstanding orderbook at c.MYR1.4bn; tenderbook at >MYR4bn.** This should keep KGB busy well into FY27. Advanced engineering works continue to make up the lion's share at 71%, followed by general contracting (18%) and process engineering (12%). >60% of the orderbook accrues from on-going jobs in Malaysia and Singapore. While there are some concerns on the sustainability of tenderbook (and hence order wins), we caution against an inordinate emphasis on the value. Sizeable tenders where outcomes are expected in 1H26 include projects in Europe (MYR1.5bn) and India (MYR1.9bn).
- **Our forecast and TP are maintained** pending the results call with management later today. Our current TP is based on 28.8x FY26F EPS, at +0.5SD of KLTEC historical mean. The exercise of the remaining in-the-money warrants – which are set to expire in July – would raise c.MYR141m (16 sen/share), providing upside risk to dividends.
- **Key risks** are softer-than-expected earnings and/or margins, weaker orderbook replenishment, and project execution delays




